Workshop for members of the African Network of Women operating in Fisheries (RAFEP)



Under the theme:

**“Raising awareness of the impacts of climate change
and economic adaptation strategies »**

Agadir, 6 February 2025

Introduction

On the sidelines of the 7th edition of the Halieutis Show, the Ministerial Conference on Fisheries Cooperation among African States Bordering the Atlantic Ocean (ATLAFCO) organized a workshop for the benefit of members of the African Network of Women operating in Fisheries (RAFEP) on February 6, 2025 in Agadir, Morocco. Under the theme "*Awareness of the impacts of climate change and economic adaptation strategies*", this event brought together experts, managers and stakeholders from the fisheries sector to reflect on the climate challenges affecting artisanal fishing communities and adaptation solutions.

The event was honored by the presence and speeches delivered on this occasion by their Excellencies **Mr. Sidi Tiémoko TOURE**, Minister of Animal and Fisheries Resources of the Republic of Côte d'Ivoire, current President of ATLAFCO, and **Mrs. Zakia DRIOUICH**, Secretary of State to the Minister of Agriculture, Maritime Fisheries, Rural Development and Water and Forests, in charge of Maritime Fisheries of Morocco, who was accompanied by several directors and senior officials of the Ministry. The speeches delivered are attached.

Also, this workshop was marked by the presence at its opening ceremony of their Excellencies the **Ambassadors of Japan and Angola to the Kingdom of Morocco**, of **Madam Ambassador-Head of the UN-Women office in Rabat** and of the representative of the **MOHAMMED VI Foundation for the Environment**.

Similarly, this workshop saw the participation of the executive and permanent secretaries of the regional fisheries bodies (**FCWC, SRFC and COREP**) partners of ATLAFCO as well as the representative of the fisheries and animal resources office of the African Union (**AU-IBAR**).

In a highly symbolic gesture, the women of RAFEP and ATLAFCO paid tribute to Her Excellency the Secretary of State with a ceremony inspired by pure African traditions, thus underlining their recognition for her commitment to women in the fisheries sector at the continental level and her support for the bodies of our Organization.

The workshop was structured around a series of technical and strategic presentations, addressing various aspects of the effects of climate change on fisheries in Africa.

These presentations are not presented here in chronological order, but according to a thematic logic facilitating their overall understanding.

Summary of interventions, debates and main themes covered :

1. Impact of climate change on fisheries resources and fishing communities

➤ **Climate change and fisheries in West Africa (SRFC)**

Presented by the Sub-Regional Fisheries Commission (SRFC), this intervention highlighted coastal erosion, changes in fish stocks and the redistribution of species due to climate change. The scarcity of resources impacts food security and fishermen's income, requiring strengthened resilience measures.

➤ **Contribution of the FCWC to strengthening the resilience of fishing stakeholders (FCWC)**

The Fisheries Committee for the West Central Gulf of Guinea (FCWC) stressed the increased vulnerability of member states to climate change. Solutions such as improving surveillance systems, strengthening port infrastructure and adopting sustainable fishing techniques were discussed.

- **Sustainable use of living marine resources in the face of the effects of climate change (ATLAFCO)**

ATLAFCO stressed that marine resource management must now integrate climate adaptation. It is imperative to harmonize regional strategies to ensure sustainable exploitation of fisheries resources, while strengthening governance and regulations.

2. Role of scientific research and institutions in adaptation to climate change

- **Role of scientific research in climate resilience (INRH)**

The National Institute for Fisheries Research (INRH) has demonstrated the importance of scientific data to anticipate climate impacts on fish stocks. Ocean acidification, rising temperatures and species migration are all phenomena requiring science-based policies.

- **Regional vision (Central Africa) to combat the effects of climate change and promote resilient development (COREP)**

The Gulf of Guinea Regional Fisheries Commission (COREP) presented a regional approach to better integrate climate issues into development strategies. Improving governance, financing adaptation initiatives and the inclusion of women were identified as key levers.

3. The place of women in resilience to climate change

- **Empowering Women in Fisheries in the Face of Climate Change (AU-IBAR)**

The role of women in the processing and marketing of fish products was highlighted by the African Union – Inter-African Bureau for Animal Resources (AU-IBAR). The need to improve their access to finance, training and modern technologies was stressed.

- **Role of RAFEP in the economic and social adaptation of women to climate change (RAFEP)**

RAFEP detailed initiatives aimed at strengthening the resilience of women in artisanal fisheries. The adoption of product valorization techniques, income diversification and awareness raising on sustainable practices are among the recommendations.

- **Effects of climate change and economic resilience of women in fisheries (RAFEP – ATLAFCO Workshop)**

This session focused on the specific challenges faced by African women in the fisheries sector. Participants discussed the social and economic impacts of climate change, highlighting local experiences and concrete solutions.

4. Adaptation strategies and innovations for the valorization of seafood products

- **Adaptation strategy for better promotion of seafood products in the face of climate change (Morocco – MSSMF)**

The Moroccan Secretariat of State for Maritime Fisheries presented the actions implemented to modernize value chains and strengthen the resilience of coastal communities. Product labeling and the promotion of sustainable aquaculture are among the solutions envisaged.

- **Artisanal shrimp fishing as a source of income for women in the face of climate change: the case of Cameroon**

This case study illustrated how climate variations affect shrimp fishing in Cameroon, disrupting shrimp reproduction and undermining the livelihoods of women processors.

- **Role of African fisheries media in raising awareness of the effects of climate change (MOSFA)**

Finally, the Media Observatory for Sustainable Fisheries in Africa (MOSFA) stressed the importance of communication and awareness raising. The media plays a key role in informing fishing communities about climate risks and sustainable practices.

5. Particularly significant participations in this workshop :

- **Mr. Houssam EL ABBOUBI**, student at Mohammed VI Polytechnic University in political science and also president of the “African Identity” club (dedicated to the promotion of African culture) raised three major observations: the impact of climate change on youth mobility and emigration, the involvement of African youth in climate governance, as well as the adaptation strategies needed to face environmental challenges.
- **Mrs. Latimad ZAIR & Mr. Ayoub ACHBARO**, Mohammed VI Foundation for the Environment describe their organization as committed to raising awareness about preserving the oceans and coastlines through various programs, including “Clean Beaches” and the “Blue Flag” label. It supports environmental education and promotes actions to protect 30% of the oceans by 2030. The emphasis is on scientific research and environmental education.
- **Ms. Meriem BOLATA** (UN-WOMEN, Rabat Office) first made an inventory in Morocco on the situation of women that the FAO described as alarming to the extent that women need to be autonomous. The UN Women project in collaboration with the Moroccan and Japanese governments consists of strengthening the capacities of these women by providing equipment, training in marketing techniques, organizing cooperatives into economic interest groups in order to better understand the markets with a more consistent production , etc.

The aim is to secure and increase women's income while training them in good hygiene practices and resource preservation, as well as training them in leadership and administrative management.

Mr Abdennaji LAAMRICH, from the Executive Secretariat, presented the actions carried out by ATLAFCO through its secretariat to promote the principle of sustainable use of marine resources.

The presentation focused on the importance of strengthening the sustainable use of living marine resources, through a governance system based on the best available scientific knowledge and advice to, among other things, sustainably exploit marine species, contribute to job creation and the stability of local populations and their well-being.

He then highlighted the effective contribution of ATLAFCO to strengthening "the voice of Africa" within international decision-making bodies on fisheries (CITES, IWC, ICCAT, COFI, etc.), by promoting the principle of sustainable development of living aquatic resources.

He also emphasized the importance of sustainable use of living marine resources to ensure food security, livelihoods, and sustainable and inclusive socio-economic development of states in the ATLAF region to address climate change.

He concluded by calling on all member states to redouble their efforts to defend this principle through the solidarity advocated by ATLAFCO as a tool for regional fisheries cooperation, particularly during the next CITES session to be held in December 2025.

6. Recommendations emerging from the discussions at the end of the session :

- Every problem must be solved on a scientific basis;
- Each problem must be resolved within the framework of collaboration, in particular pollution in all its forms but especially plastic, and it should be noted that there is only "one ocean which is interconnected";
- Call to ATLAFCO for the creation of an exchange platform on the impact of climate change (coastal erosion and others);
- Reflection at ATLAFCO level on the possibility of organizing a symposium on pollution and more particularly on plastic with the participation of international experts;
- Approach the RAFEP level of the Maroc Bleu foundation to benefit from their experience in "Blue Education";
- That each female representative of RAFEP member countries should research the UN Women Office closest to their country in order to benefit from its assistance;
- Be sure to apply three essential rules:
 - ❖ Transfer of know-how;

- ❖ Capacity building;
- ❖ Twinning of initiatives.

Conclusion :

This workshop highlighted the multiple challenges posed by climate change on the fisheries sector in Africa, but also the opportunities for better adaptation.

The discussions made it possible to identify concrete avenues for action, particularly in terms of fisheries governance, product development, training and the integration of women in adaptation strategies.

The commitment of the participants and institutions present demonstrates the collective desire to build an African fisheries sector that is more resilient to climate challenges.

The need for capacity building, increased regional cooperation and support for women's initiatives was widely recognised.

At the end of the sessions, all participants thanked ATLAFCO, its Secretariat and OFCF for the efforts made for the benefit of member states in general and for women in fisheries in Africa in particular.

Also, the participants highly recognized the expertise of the panelists, praised the quality of their interventions and appreciated the content of the debates and discussions during all phases of this workshop.

First of all, let me welcome you to Morocco to participate in the 7th edition of the International Halieutis Exhibition in Agadir and also in the work of this important workshop to strengthen the capacities of women in fisheries in Africa.

ATLAFCO, through the inclusion of the principle of sustainable use of living marine resources, has undertaken awareness-raising efforts in several areas related to the processing and enhancement of fishery products through the organization of practical workshops to share the best methods of mitigating the impacts of climate change on fishermen's income.

Today's workshop is part of this spirit of continuity to enable women active in the African fisheries sector to take into account environmental changes by innovating and drawing on their high adaptability to perpetuate their activity, maintain their autonomy and secure income, because as we all know, African women fishermen remain a key player in the seafood value chain in particular, and in the African social economy in general.

Therefore, we must act, as governments, in a collegial, collective and united manner so that the fisheries sector and its fishery products in Africa can contribute more to food security and the well-being of fishing populations who directly depend on marine resources despite the current context marked by the post- Covid and other uncontrollable exogenous factors.
