



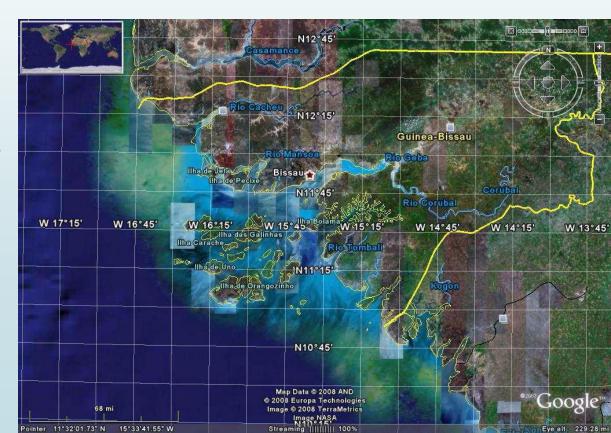

CONTEXT

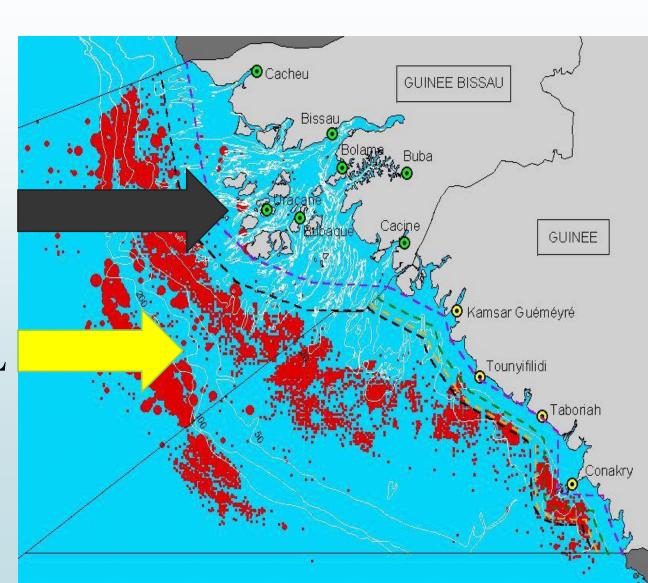
- □ Country's surface area: 36,125 km2;

COMPETENT AUTHORITY

The National Institute for the Inspection and Control of Fishing Activities – FISCAP-IP is the CA responsible for supervising and coordinating the national inspection system for fishing vessels and pirogues in waters under national sovereignty and jurisdiction.

FISCAP-IP is a technical and operational body whose main mission is to ensure compliance with the law, regulations and conservation and management measures in relation to the exercise of fishing activities in waters under the sovereignty and jurisdiction of the Republic of Guinea-Bissau, supervising these same activities, with a view, on the one hand, to preventing, combating and eliminating Illegal, Unreported and Unregulated fishing, and on the other hand, to contributing to the management, conservation and sustainable exploitation of fishery resources.

RESPONSIBILITY

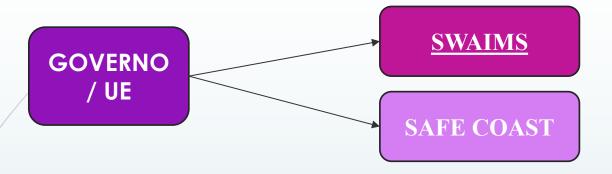
- ✓ Ensure that technical inspections of vessels are carried out in accordance with the law;
- ✓ ✓ Ensure that fishing activities, including related transhipment activities in waters under national jurisdiction, are carried out in accordance with applicable legal provisions;
- ✓ Implement and enforce international instruments that represent a commitment on the part of the Republic of Guinea-Bissau in terms of fishing control and inspection;
- ✓ ✓ Issue catch certificates attesting that the catches do not come from illegal, unregulated and unreported (IUU) fishing;
- ✓ ✓ Organize, direct and coordinate the Fisheries Surveillance Center for the purposes of monitoring, tracking and controlling vessels via satellite.

MARITIME SAFETY IN GUINEA-BISSAU

With a vast coastline, has faced significant challenges related to illicit and criminal activities:

- ✓ IUU fishing;
- √Drug trafficking;
- ✓ Piracy;
- ✓ Illegal immigration;
- ✓ Shipwrecks, as a result of accidents, which resulted in damage and loss of many lives, particularly in small transport vessels.

MEASUREMENTS



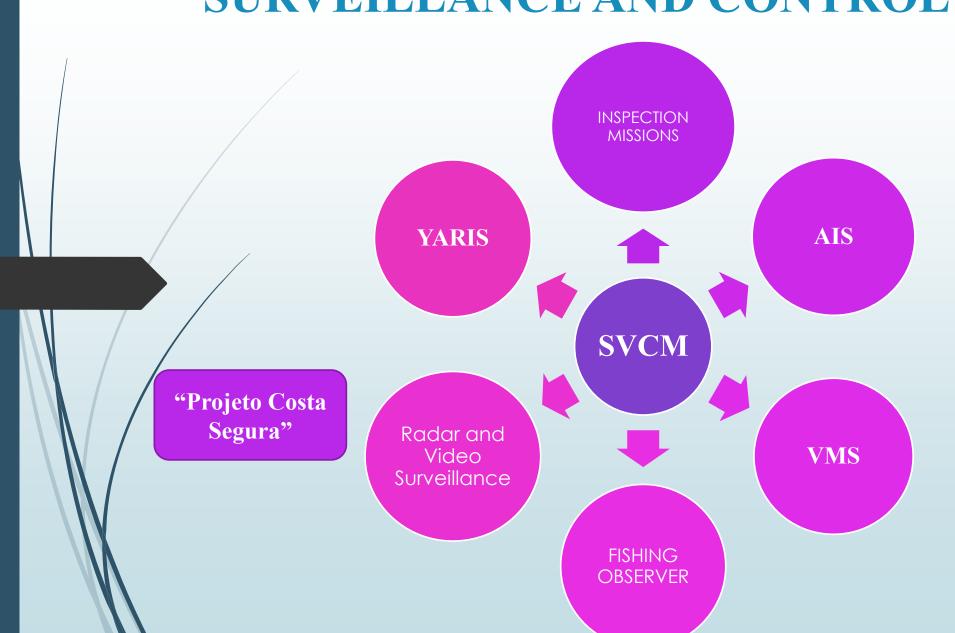
As a measure to combat these illicit and criminal activities, as well as to reduce accidents at sea, the Government, in collaboration with international partners, namely the European Union, is investing in technology and cooperation to strengthen its maritime security system, with the aim of protecting its territorial waters, promoting navigation safety and combating illicit activities, through technical and financial support and assistance, within the scope of the "Support for Integrated Maritime Security in West Africa" (SWAIMS) and "SAFE COAST".

This measure aims to reinforce the measures integrated in the Cooperation Protocol on the Monitoring, Monitoring, Control and Inspection of Fishing Activities, signed between the Ministry of Fisheries and Maritime Economy, the Ministry of National Defense and the Ministry of the Interior.

OBJECTIVE

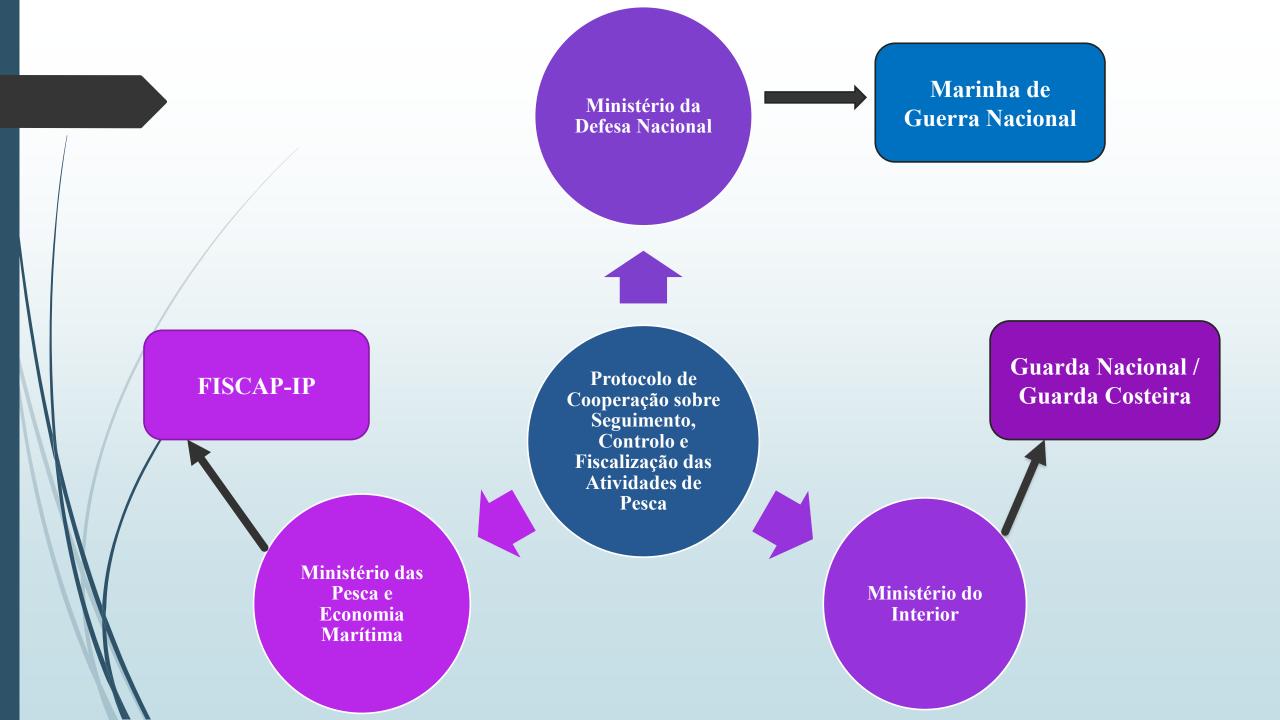
- ☐ Improve capacity to monitor and control maritime activities;
- Strengthen legal governance and law enforcement frameworks to better support maritime security;
- Improve operational capabilities and law enforcement responses through strengthening institutional and tailored technical capabilities;
- □ Detect, monitor and control vessels;
- ☐ Prevent, combat and eliminate Illegal, Unreported and Unregulated fishing.

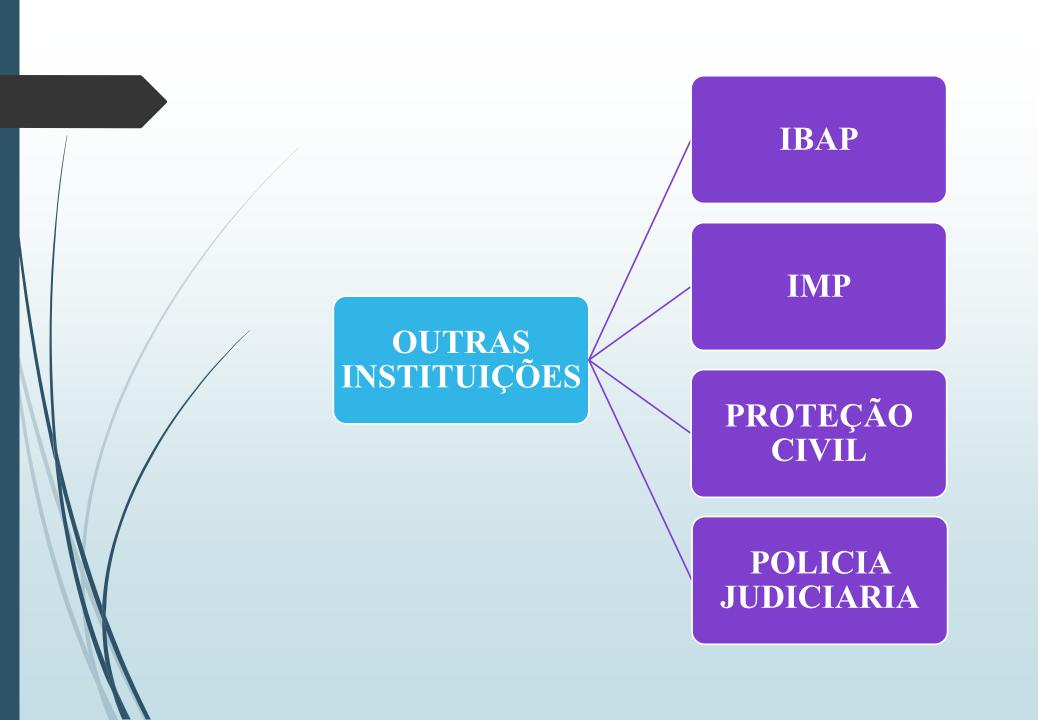
SURVEILLANCE AND CONTROL AT SEA



OPERATION

- ✓ The system enables continuous monitoring of maritime activities, including vessel detection, speed and automatic identification.
- ✓ ✓ With the installation of the advanced radar system and high-tech cameras, the aim is to cover the entire coast of Guinea-Bissau, thus enabling more precise and comprehensive surveillance..

CONSTRAINTS

- ✓ Political and governmental instability;
- ✓ ✓ Existing legal framework not in line with new requirements and challenges;
- ✓ Lack of harmonization of international instruments aimed at combating JUU fishing and other illegal activities;
- ✓ Lack of a national maritime security coordination structure; ✓ Lack and insufficiency of beacons and signaling lights;
- ✓ Insufficient naval monitoring resources (existing resources are obsolete, with the exception of the patrol vessel "Okinka Pap");
- ✓ ✓ Lack of investment in maritime infrastructure.

RECOMMENDATION

- ✓ Updating the existing legal framework;
- ✓/✓ Harmonisation of international maritime safety instruments
- ✓ Creation and institutionalisation of a National Committee for Maritime Safety and the Prevention of Accidents at Sea;
- √ √ Acquisition and allocation of more nautical monitoring resources;
- ✓ ✓ Acquisition of aerial resources (drones);
- ✓ Construction of an infrastructure for the National Committee for Maritime Safety and the Prevention of Accidents at Sea;
- ✓ ✓ Acquisition of surveillance and monitoring equipment
